### V. Cookies

## **VI. Phone, e-Mail and online forms**

When you call me, your call data will be stored pseudonymously on the respective terminal device and with the telecommunications provider used. The data will be deleted as soon as the business case has been terminated and the legal requirements allow it.

## **VII. In general**

For all applications that support me, the principle of data economy applies. Everyone receives and processes only the data that he also needs for it.

### **Duration of data storage**

After fulfillment of the contract, your data will no longer be actively used by me, but only stored to the extent necessary for the duration of the tax and commercial retention periods. With the expiration of this period, the data will be deleted immediately. Provided that you have actively consented to the further processing of your data, I will do so, if necessary, until you want it to be deleted. The deletion is then possible at any time. For this, please contact me by e-mail or letter to my above addresses.

### **Right to information**

Of course, you can make use of your right to information at any time. This means that you can contact me at the above addresses and I will provide you with information about all data that I have collected and processed from you. If you wish to revoke your consent to data processing, please send me an e-mail or a letter to the above addresses.

This also applies to the request for deletion or the use of the right to data transmission.

### **Right of appeal**

You are free at any time to lodge a complaint with the relevant supervisory authority if I am in breach of data protection.
